Hazard

Infections due to dogs; harming of people caused by dog bites

Human behaviour that is intended to be caused after understanding the safety sign's meaning

Not taking dogs into a prohibited area

Human behaviour that is intended to be prevented

Taking dogs into a prohibited area

Need

To keep dogs away from certain areas (e.g. schools, hospitals, play areas, food preparation areas), since dogs can injure people by biting them or carry infections or dirt into protected areas.

Additional information

Test data obtained according to ISO 9186-1 are not available from more than one country. Findings from national testing, however, showed that the graphical symbol did not reach the criteria of acceptability. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
