Standard Terminology for Livestock, Meat, and Poultry Evaluation Systems¹

This standard is issued under the fixed designation F 2463; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon (ϵ) indicates an editorial change since the last revision or reapproval.

1. Scope

1.1 This terminology contains related definitions and descriptions of terms used or likely to be used in livestock, meat, and poultry evaluation standards. The purpose of terminology is to promote clear understanding and interpretation of the standards in which they are used.

1.2 This standard does not purport to address all of the safety concerns, if any, associated with its use. It is the responsibility of the user of this standard to establish appropriate safety and health practices and to determine the applicability of regulatory limitations prior to use.

accurate, adj—when performance or value of a device, as determined by tests made with a suitable reference material, conforms to the standard within the allowable tolerance.

carcass, *n*—harvested animal, whether eviscerated or not. **F 2341, F 2343**

Discussion—A carcass may or may not be split into separate sides, one or both sides may be measured or evaluated.

carcass primal, n—basic major cuts into which carcasses and sides are separated.

carcass subprimal, n—smaller cuts derived from primal cuts.

evaluation device, *n*—equipment designed to measure composition or quality constituents used to determine the value of live animals, carcasses, and individual cuts of meat.

evaluation system, *n*—device or group of devices used to measure and record composition or quality constituents used to determine the value of live animals, carcasses, and individual cuts of meat. **F 2340, F 2341, F 2342, F 2343**

independent third party, *n*—unbiased person or entity that is knowledgeable with subject matter expertise.

livestock, *n*—cattle, sheep, swine, and other domesticated meat animals. **F 2341**, **F 2342**, **F 2343**

meat, *n*—edible product(s) harvested by the meat-packing industry. **F 2341**, **F 2342**, **F 2343**

poultry, *n*—chickens, turkeys, ducks, geese, and other domesticated fowl. **F 2341, F 2342, F 2343**

quality constituents, *n*—measurable characteristic, such as, but not limited to pH, marbling, tenderness, or color. **F 2342, F 2343**

value, commerce, *n*—measure of economic worth in commerce. **F 2340, F 2341, F 2343**
