**Hazard**

Not being able to locate the eyewash station which is provided to assist in the clearance of eye contamination from substances which can lead to eye damage and loss of sight, if not cleared sufficiently quickly

**Human behaviour that is intended to be caused after understanding the safety sign's meaning**

Being aware of the location of an eyewash station sufficiently quickly at the time of need

**Human behaviour that is intended to be prevented**

Not being aware of the location of an eyewash station sufficiently quickly at the time of need

**Need**

The use of an eyewash can reduce the risk of damage to eyes and loss of sight following contamination from substances.

**Field of application**

In workplaces

**Format of application**

Safety signing, safety manuals and notices

**Context of use**

In areas where eye contamination can take place and eyewash stations are provided

**Additional information**

The first aid cross may be replaced with another element appropriate to cultural requirements of the target group.

Test data obtained according to ISO 9186-1 are not available. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
