## AMENDMENT 55: Safety sign W023: Warning; Corrosive substance

**IMPORTANT** — The colours represented in the electronic file of this International Standard can be neither viewed on screen nor printed as true representations. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
