## AMENDMENT 60: Safety sign W028: Warning; Oxidizing substance

**IMPORTANT** — The colours represented in the electronic file of this International Standard can be neither viewed on screen nor printed as true representations. <b>Additional information</b> Test data obtained according to ISO 9186-1:2007 are not available from more than one country. Findings from national testing, however, showed that in one country the graphical symbol exceeded the criteria of acceptability. Consequently, a supplementary text sign may be used to increase comprehension. If the safety sign is supplemented by manuals, instructions or training, a supplementary text sign may not be required.
