10 Tape speed

Replace this clause by the following new clause:

The rated speed during reproduction shall be in a geometrical progression with the divisor 2 commencing at 76,2 cm/s (30 in/s). The speed and tolerances apply to machines operating from supplies having frequencies and voltages as specified by the manufacturer. Speed fluctuations requirements (wow and flutter) shall be measured in accordance with IEC 386 and amendment No. 1.
