B.2

Add a new subclause B.2.2:

"**B.2.2** Suitable device for type 2B, capable of applying a force of $(167 \pm 2,1)$ N for age group 0 to 4 years and/or a force of (279 ± 5) N for age group 0 – 8 years."

B.3

The text of B.3 becomes "**B.3.1**" and add a new subclause B.3.2:

"**B.3.2** For type 2B, apply the force according to B.2.2."

C.2.2

Replace text in C.2.2 by

"Suitable device for type 2B, capable of applying a force of $(167 \pm 2,1)$ N for age group 0 to 4 years and/or a force of (279 ± 5) N for age group 0 to 8 years."

Change old C.2.2 to C.2.3

C.3.1

Add the following text to C.3.1: "For type 2B, apply the force according to C.2.2."
