Conformant with ISO Guide 78¹⁾, this Amendment supports regional technical regulations for machinery safety according to the principles of UNECE Recommendation L²⁾. It comprises minor technical changes to the existing International Standard, aimed at ensuring compliance of the current edition of ISO 14122-1 with the relevant Essential Requirements of New Approach Directive 2006/42/EC on machinery, which replaced New Approach Directive 98/37/EC and entered into force on 2009-12-29 without a transition period.
