Part 5: Assessment of degree of flaking

1 Scope

This part of ISO 4628 describes a method for assessing the degree of flaking of coatings by comparison with pictorial standards, using the designation system defined in ISO 4628-1.

ISO 4628-1 defines the system used for designating the quantity and size of defects and the intensity of changes in appearance of coatings and outlines the general principles of the system. This system is intended to be used, in particular, for defects caused by ageing and weathering, and for uniform changes such as colour changes, for example yellowing.

3 Terms and definitions

For the purposes of this document, the following terms and definitions apply.

3.1

degree of flaking

rating characterizing flaked areas in a coating in terms of quantity, size and depth

4 Assessment

Assess the quantity of flaking by reference to Table 1 and using as an example Figure 1 or 2, depending on the type of flaking.

NOTE Figure 1 shows flaking without preferential direction and Figure 2 shows flaking in one preferential direction due to anisotropy of the substrate.
