Foreword

The proposal to endorse IEC 335-2-66:1993, document CLC/TC 61 (SEC) 919, was circulated under the enquiry procedure in September 1993. This proposal was discussed during the Oslo meeting in April 1994, when it was decided to submit a draft for EN 60335-2-66 to the formal vote.

This draft was circulated in January 1995 and was ratified by CENELEC as EN 60335-2-66 on 1995-07-04.

This European Standard has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1996-04-01
- date on which national standards conflicting with the EN have to be withdrawn (dow) 1998-04-01

For products which have complied with the relevant national standard before 1998-04-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2003-04-01.

This standard has to be used in conjunction with EN 60335-1, Safety of household and similar electrical appliances, Part 1: General requirements. It was established on the basis of the 1994 edition of that standard. Amendments and revisions of part 1 have also to be taken into account and the dates when such changes become applicable will be stated in the relevant amendment or revision of part 1.

This part 2 supplements or modifies the corresponding clauses of EN 60335-1, so as to convert it into the European Standard: Safety requirements for water-bed heaters.

Where a particular subclause of part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. Where this standard states "addition", "modification" or "replacement", the relevant text of part 1 is to be adapted accordingly.

Subclauses which are additional to those in part 1 are numbered starting with 101.

There are no special national conditions causing a deviation from this European Standard, other than those listed in annex ZA to EN 60335-1.

There are no national deviations from this European Standard, other than those listed in annex ZB to EN 60335-1.

FOREWORD

- 1) The IEC (International Electrotechnical Commission) is a worldwide organization for standardization comprising all national electrotechnical committees (IEC National Committees). The object of the IEC is to promote international cooperation on all questions concerning standardization in the electrical and electronic fields. To this end and in addition to other activities, the IEC publishes International Standards. Their preparation is entrusted to technical committees; any IEC National Committee interested in the subject dealt with may participate in this preparatory work. International, governmental and non-governmental organizations liaising with the IEC also participate in this preparation. The IEC collaborates closely with the International Organization for Standardization (ISO) in accordance with conditions determined by agreement between the two organizations.
- 2) The formal decisions or agreements of the IEC on technical matters, prepared by technical committees on which all the National Committees having a special interest therein are represented, express, as nearly as possible, an international consensus of opinion on the subjects dealt with.
- 3) They have the form of recommendations for international use published in the form of standards, technical reports or guides and they are accepted by the National Committees in that sense.
- 4) In order to promote international unification, IEC National Committees undertake to apply IEC International Standards transparently to the maximum extent possible in their national and regional standards. Any divergence between the IEC Standard and the corresponding national or regional standard shall be clearly indicated in the latter.
- 5) The IEC provides no marking procedure to indicate its approval and cannot be rendered responsible for any equipment declared to be in conformity with one of its standards.

This part 2 supplements or modifies the corresponding clauses in IEC 335-1, so as to convert it into the IEC standard: Safety requirements for electric water-bed heaters.

Where a particular subclause of part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. Where this standard states "addition", "modification" or "replacement", the relevant text in part 1 should be adapted accordingly.

Words in **bold** in the text are defined in clause 2.

2 Subclauses and figures which are additional to those in part 1 are numbered starting from 101.

The following differences exist in some countries:

- Clause 3: The d.c. component in the appliance neutral is limited (Australia).
- 6.1: Class I appliances are not allowed (China, Czechoslovakia, Norway and Yugoslavia).
- 7.12.1: The surface configuration of the mattress is to be stated (USA).
- 11.8: The temperature rise is not to exceed 65 K (USA).
- 11.101: The test is not conducted (USA).
- 21.101: Different tests are used to evaluate mechanical strength (USA).
- 24.101: Self-resetting thermal cut-outs are allowed (USA).

SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES

Part 2: Particular requirements for water-bed heaters

1 Scope

This clause of part 1 is replaced by:

This standard deals with the safety of electric **water-bed heaters** and their associated control units, for household and similar purposes, their **rated voltage** being not more than 250 V.

Appliances not intended for normal household use, but which nevertheless may be a source of danger to the public, such as appliances intended to be used in hotels, are within the scope of this standard.

So far as is practicable, this standard deals with the common hazards presented by appliances which are encountered by all persons in and around the home.

This standard does not in general take into account

- the use of appliances by young children or infirm persons without supervision;
- playing with the appliance by young children.

- 1 Attention is drawn to the fact that:
- for appliances intended to be used in vehicles or on board ships or in aircraft, additional requirements may be necessary;
 - for appliances intended to be used in tropical countries, special requirements may be necessary;
 - in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities.
- 2 This standard does not apply to appliances:
- for medical purposes (IEC 601);
 - intended for immersion in water during use.

2 Definitions

This clause of part 1 is applicable except as follows:

2.2.9 Replacement:

normal operation: The heater and its control unit are installed with a water mattress in accordance with the instructions for use.
