Foreword

The proposal to endorse amendment 3:1992 to IEC 335-2-34:1980, document CLC/TC 61(SEC)906, was circulated under the CENELEC enquiry procedure in July 1993. This proposal was discussed during the Oslo meeting in April 1994, when it was decided to submit a draft for an amendment to the voting procedure.

This draft was circulated as prAB in October 1994 and was ratified by CENELEC as amendment A2 on 1995-05-15.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date of announcement of the amendment at national level (doa) 1995-10-01
- latest date of publication of a harmonized national standard (dop) 1996-01-01
- date of withdrawal of conflicting national standards (dow) 1998-01-01

For products which have complied with HD 277 S1:1985 including its amendment A1:1989 before 1998-01-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2003-01-01.

This amendment supplements or modifies the corresponding clauses of HD 277 S1 and its amendment.

iTeh STANDARD PREVIEW

As a consequence of endorsing amendment 3 to IEC 335-2-34 that supersedes amendment 1 (including corrigendum) and amendment 2 to IEC 335-2-34, amendment A1 to HD 277 S1 is withdrawn.

The modifications in the preface and subclauses 1.1, 22.33 and 29.1 have their origin in the amendments 1 and 2 to the IEC standard.
