#### **AMENDMENT 1**

Add a new sentence at the end of subclause 6.5 so that it reads

**"6.5 Pipettes**, having a nominal capacity of 1 ml, graduated in 0,1 ml divisions.

Blow-out pipettes shall not be used. However, micropipettes of capacity 1,0 ml  $\pm$  0,01 ml can be used.
