

## AMENDMENT 68: Safety sign E018: Turn anticlockwise to open

**IMPORTANT** — The colours represented in the electronic file of this document can be neither viewed on screen nor printed as true representations. For the purposes of colour matching, see ISO 3864-1 which provides colorimetric and photometric properties together with, as a guideline, references from colour order systems.

Add safety sign E018 to the alphabetical summary in Table 1 and to category E in Tables 2 and 3 as follows:

**Safety sign E018: Turn anticlockwise to open**

	<b>Reference No.</b> <p style="text-align: right;"><b>ISO 7010-E018</b></p>
	<b>Referent</b> <p style="text-align: center;"><b>Turn anticlockwise to open</b></p>
	<b>Function</b> To signify that the doorknob of a security door on an escape route must be turned in an anticlockwise direction in order for the opening device to operate
	<b>Image content</b> Doorknob with semicircular anticlockwise arrow
<b>Hazard</b> Being unable to open a door on an escape route which has a security lock and an emergency opening device, in the event of an emergency	
<b>Human behaviour that is intended to be caused after understanding the safety sign's meaning</b> Turning the doorknob in an anticlockwise direction in order to open a door on an escape route which has a security lock, in the event of an emergency	
<b>Related referents</b> ISO 7010-E019	
<b>Additional information</b> This safety sign is intended to be used only on doors with a security locking mechanism.  Test data obtained according to ISO 9186-1:2007 are not available. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
