## AMENDMENT 70: Safety sign M024: Use this walkway

**IMPORTANT** — The colours represented in the electronic file of this document can be neither viewed on screen nor printed as true representations. <p><b>Hazard</b> Areas unsafe for pedestrians</p> <p><b>Human behaviour that is intended to be caused after understanding the safety sign's meaning</b> Pedestrians using the designated walkway</p> <p><b>Related referents</b> ISO 7010-P004</p> <p><b>Additional information</b> Test data obtained according to ISO 9186-1:2007 are available from more than one country. Findings from testing showed that the safety sign did not reach the criteria of acceptability. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.</p>
