Additional information

Test data obtained according to ISO 9186-1:2007 are available from more than one country. Findings from testing showed that the safety sign did not reach the criteria of acceptability. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
