This amendment A11 modifies the European Standard EN 60730-2-2:1991; it was approved by CENELEC on 1995-02-15. CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

Foreword

This amendment was prepared by the Technical Committee CENELEC TC 72 Automatic controls for household use.

The text of the draft was submitted to the Unique Acceptance Procedure and was approved by CENELEC as amendment A11 to EN 60730-2-2:1991 on 1995-02-15.

This document modifies the corresponding clause of EN 60730-2-2:1991.

The following dates were fixed:

- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1996-03-01
- latest date by which the national standards conflicting with the amendment have to be withdrawn (dow) 1996-03-01

The following modification applies to the text of EN 60730-2-2:1991:

21 Resistance to heat, fire and tracking

21.2.6 Replace the fourth and fifth dashed items by:

For parts supporting live parts of controls other than in-line controls intended to be incorporated in appliances within the scope of EN 60335-1, the test is made at the declared temperature plus $20\text{ °C} \pm 2\text{ °C}$ but at least $125\text{ °C} \pm 2\text{ °C}$.
