FOREWORD

This amendment has been prepared by IEC technical committee 72: Automatic controls for household use.

The text of this amendment is based on the following documents:

Full information on the voting for the approval of this amendment can be found in the report on voting indicated in the above table.

NOTE – IEC 730-2-7 originally referred to the first edition of IEC 730-1 (1986) modified by its amendment 1 (1990) and amendment 2 (1991). This amendment enables IEC 730-2-7 to be used with the second edition (1993) of IEC 730-1. The attention of the reader is drawn to the English terminology "Appendix" which has been replaced by "Annex" and by the reference to the "première partie" in the French text which has been replaced by the reference to the "partie 1". These terms are perfectly interchangeable.

PREFACE

1.1 Add the following paragraph: standards.iteh.ai)

This standard is also applicable to individual timers utilized as part of a control system or timers which are mechanically integral with multifunctional controls having non-electrical outputs.

1.1.1 Add the following paragraphs:

Timers for equipment not intended for normal household use, but which nevertheless may be used by the public, such as equipment intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

730-2-7 Amend, 1 © IEC:1994

Throughout this standard the word "equipment" means "appliance and equipment".

This standard does not apply to timers designed exclusively for industrial applications.

- 1.1.2 In the explanatory note, replace the reference to IEC 328 by the reference to IEC 1058-1.
- 1.4 Replace this subclause by:

This standard applies also to timers incorporating electronic devices, requirements for which are contained in annex H.

1.5 Normative references
