The test report shall show the content of reducing carbohydrates expressed as glucose on % dry weight basis, the method used and reference shall be made to this International Standard. The test report shall also include:

- all details required for a complete identification of the sample;
- the moisture content and the test method used;
- any special features observed during the analysis;
- any working conditions that are not specified in this method or are considered as optional, and that could have affected the results.
