This amendment A51 modifies the European Standard EN 60335-2-5:1989; it was approved by CENELEC on 1995-03-06. CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

Up-to-date lists and bibliographical references concerning such national standards may be obtained on application to the Central Secretariat or to any CENELEC member.

This amendment exists in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CENELEC member into its own language and notified to the Central Secretariat has the same status as the official versions.

Foreword

A proposal to amend EN 60335-2-5:1989, document CLC/TC 61 (FR) 268, was discussed during the El Campello meeting in October 1993, when it was decided to submit a draft for an amendment to the Unique Acceptance Procedure (UAP).

The draft was circulated as prAG in June 1994 and was ratified by CENELEC as amendment A51 on 1995-03-06.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date of publication of an identical national standard (dop) 1995-10-01
- date of withdrawal of conflicting national standards (dow) 1997-07-01

For products which have complied with EN 60335-2-5:1989 including its amendments A1:1990, A2:1992 and A3:1992 before 1997-07-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2002-07-01.

This amendment supplements or modifies the corresponding clauses of EN 60335-2-5:1989 and its amendments.

EN 60335-2-5:1989 including this amendment has to be used in conjunction with EN 60335-1:1988, including its amendments A2:1988, A5:1989, A6:1989, A51:1991, A52:1992, A53:1992, A54:1992 and A55:1993.

There are no special national conditions causing a deviation from this amendment.

There are no national deviations from this amendment.

NOTE - Amendment numbers commencing A1 refer to the endorsement of IEC amendments, while those commencing A51 originate in CENELEC.

19 Abnormal operation

19.101 Replace the last but one dashed item by:

- failure or blocking of the mechanical part of a water level switch.
This fault condition is not applied if the cross section of the tube supplying the air-reservoir with water is greater than 5 cm² with a minimum dimension of 1 cm and if the air-reservoir outlet is at least 2 cm above the maximum water level. The tube connecting the air-reservoir and the water level switch is to be fixed so that there is no likelihood of bending or pinching.
