Page 2, Clause 3.1.5

Delete Clause 3.1.5.

Page 9, Clause 5.4.1.5

Add the following sentence as the last sentence of Clause 5.4.1.5:

“This provision does not apply to track-laying tractors (e.g. differential, articulated, and combination wheeled and track-laying tractors).”

Page 9, Clause 5.4.16

Add the following sentence as the last sentence of Clause 5.4.1.6:

“This provision does not apply to track-laying tractors (e.g. differential, articulated, and combination wheeled and track-laying tractors).”

Page 12, Clause 5.8.1.2

Replace the existing text by the following:

“The performance of the steering equipment shall not be adversely affected by electromagnetic disturbances according to ISO 14982.”

Page 12, Clause 5.8.2.1

Replace the existing text by the following:

“Testing and verification shall be in accordance with Annex A.4.”

Page 14, Annex A, Clause A.3.1

Replace the existing text of the first paragraph by the following:

“When legally required, the manufacturer shall develop and maintain a documentation package which gives access to the basic design of “the system” and the means by which it is linked to other tractor systems or by which it directly controls output variables.”
