	<b>Reference No.</b> <b>ISO 7001 - PI PF 045</b>
	<b>Referent</b> <b>Accessibility, limited walking capability</b>
	<b>Function</b> To indicate accessibility for people with limited walking capability.
	<b>Image content</b> Leaning human figure viewed from the side, walking frame.
<b>Human behaviour that is intended to be caused after understanding the public information symbol's meaning</b> Being aware that a place is accessible for people with limited walking capability.	
<b>Need</b> When information is needed about the accessibility of a place for people with limited walking capability.	
<b>Related meanings</b> PI PF 006 Full accessibility.	
<b>Field of application</b> Public facilities.	
<b>Context of use</b> This information appears on information-boards or in guide-books, on a sign or door.	
<b>Intended user population</b> General population.	
<b>Age of user</b> Any.	
<b>Additional information</b> Test data obtained according to ISO 9186-1:2007 are not available. Consequently, it is recommended that this symbol is accompanied by text to increase comprehension.
