Cover page, French title

In the French version of the title of ISO 16039, replace “*Machines pour le pavage*” by “*Machines à coffrage glissant*”.

Page 4, 4.4.1 Basic equipment

In the third list item, replace “width” by “width and depth”.

Page 5, 6.3.2, Specifications

In the ninth list item, replace “crawler plates” by “track pads”.

Page 7, 6.8, Additional features of a slipform paver

In the ninth list item, replace “rubber” by “non-metallic (e.g. rubber, polyurethane) or steel”.

Page 8, 6.9, Additional equipment

In the fourth list item, add “or plough” immediately after “auger”.

Page 10, Figure A.2

In item no. 14 in the legend to Figure A.2, delete the abbreviation “HF” so that the key item reads simply “vibrators”.
