Note: Due to fact that the Framework Partnership Agreement between the Commission and CEN & CENELEC is not signed yet, there are currently no New Approach Consultants in place for 2014. Therefore the provisions of CEN-CENELEC Guide 15 cannot be met.

EN 13089:2011/FprA1:2014 (E)**1 Modification to Clause 6, Marking**

Replace the existing text with the following:

"Ice-tools shall be marked clearly, indelibly and durably with at least the following:

- a) name of the manufacturer or its authorized representative in the European Union;
- b) category to which the ice-tool belongs in accordance with 3.2 and 3.3:
 - 1) for non-interchangeable picks:
 - i) if the shaft and the pick are type 2, a "T" surrounded by a circle of minimum 10 mm on the shaft;
 - ii) no category marking in any other case;
 - 2) for interchangeable picks:
 - i) if the shaft is type 2, a "T" surrounded by a circle of minimum 10 mm on the shaft;
 - ii) if the pick is type 2, a "T" surrounded by a circle of minimum 10 mm on the pick;
 - iii) no category marking in any other case;
- c) the following pictogram, instructing the user to see the information supplied by the manufacturer:

2 Modification to Clause 7, Information to be supplied by the manufacturer

Replace c) in the existing list with the following:

- "c) meaning of any markings on the product, e. g. explanation of type marking, if necessary;"
