Text of A1 to EN 50436-2:2014

Replace Clause “5 General test methods” by the following:

5 General test methods

This clause of EN 50436-1 is applicable excepted as follows:

Replace the third paragraph of 5.1 by the following:

Accessory devices of the alcohol interlock authorized by the manufacturer as being part of the alcohol interlock system and which are intended to be used in the vehicle during operation shall be tested according to this European Standard. For example, cameras or GPS systems generating data related to event data of the alcohol interlock are to be tested. Accessory devices handling or transferring data, that are not provided by the manufacturer of the alcohol interlock, do not have to be tested according to this European Standard.
