## 4.2 Replace "Under consideration" by:

## 4.2 Requirements where no product is being released under EN 123000

An approved company may have no customer requiring release of printed boards to EN 123000 for a considerable period. Where this period is greater than three months it is implicit that Group C inspection required by the appropriate Sectional Specification must still be carried out. The CTPs produced for this testing shall be considered to be released batch, and therefore also liable to Group A and Group B inspection.

This requirement ensures that production process consistency is demonstrated and also enables the compilation of RCE information.

## 4.3.2 Add after the first paragraph:

After completing ten consecutive satisfactory inspections of any individual Group B characteristic, the Chief Inspector may elect to conduct that inspection at intervals of three months. A subsequent failure shall cause the inspection to revert to a lot-by-lot frequency until a further ten consecutive satisfactory inspections have been achieved. Records of changes shall be maintained by the Chief Inspector, and be made available to the ONS.
