	<p>Function</p> <p>To signify that the liferaft must be lowered in launch sequence</p>
	<p>Image content</p> <p>Liferaft on single fall, arrow pointing down, two wavy lines</p>
<p>Hazard</p> <p>The liferaft is not lowered to the water at the appropriate time and subsequently there is not enough survival craft in the water for embarkation</p>	
<p>Human behaviour that is intended to be caused after understanding the safety sign's meaning</p> <p>Lowering the liferaft at the appropriate time</p>	
<p>Related referents</p> <p>ISO 7010-E038, ISO 7010-E039</p>	
<p>Additional information</p> <p>Test data obtained according to ISO 9186-1:2007 are not available. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.</p>
