#### **3.1.9** Add the following as a new last paragraph.

For steam cleaners intended to clean horizontal surfaces, the sheet of stainless steel is horizontal and the appliance is moved forward and backward over a length of 1 m at a rate of 15 cycles per minute instead of up and down. No additional force other than the weight of the appliance is applied.

#### 22 Construction

**22.7** In the requirement, add "and instantaneous steam cleaners" after "Pressurised appliances".
