EN 13451-1:2011/prA1:2015 (E)**1 Modification to Clause 2, Normative references**

Just before the last reference to EN ISO 12100, add the following new one:

"CEN/TS 16165, *Determination of slip resistance of pedestrian surfaces — Methods of evaluation*".

2 Modification to 4.1.1, General

Delete the 3rd paragraph:

"When tested in accordance with Annex C, the equipment shall not show any cracks or damage. Deformation shall remain within the elastic field.".

3 Modification to 4.1.2.2, Use of stainless steel

In the 2nd paragraph, replace "Annex G" with "Annex F".

4 Modification to 4.8, Slip resistance

Replace the last sentence with the following one:

"For surfaces of the equipment where the user can stand or walk with bare feet, which may not be tested in accordance with Annex E, CEN/TS 16165 gives alternate test methods.".

5 Modification to Annex F (normative), Alternate method for the determination of resistance to slipping

Delete Annex F (and modify the numbering of Annex G and its clauses and subclauses accordingly, along with the cross-references to the latter annex, throughout the whole document).

6 Modification to G.1 (old numbering), General

In the 3rd paragraph, replace "Annex G" with "Annex F".

7 Modification to G.2.3.1 (old numbering), General

Replace the 4th list indent (steel 1.4571) with the following one:

"

— 1.4571 (X6CrNiMoTi17-12-2);".
