This standard is issued under the fixed designation A662/A662M; the number immediately following the designation indicates the year of original adoption or, in the case of revision, the year of last revision. A number in parentheses indicates the year of last reapproval. A superscript epsilon ( $\varepsilon$ ) indicates an editorial change since the last revision or reapproval.

### 1. Scope \*

1.1 This specification<sup>2</sup> covers three grades of carbon-manganese-silicon steel plates intended primarily for service in welded pressure vessels where improved low temperature notch toughness is important.

1.2 The maximum thickness of plates is limited only by the capacity of the composition to meet the specified mechanical property requirements; however, current practice normally limits the maximum thickness of plates furnished under this specification to 2 in. [50 mm].

1.3 Grades A, B, and C comply substantially with the requirements of ISO Pressure Vessel Steels P9, P15, and P18, respectively. 1.4For1.4 For plates produced from coil and furnished without heat treatment or with stress relieving only, the additional requirements, including additional testing requirements and the reporting of additional test results, of Specification A 20/A 20MA20/A20M apply.

1.5 The values stated in either inch-pound units or SI units are to be regarded separately as standard. Within the text, the SI units are shown in brackets. The values stated in each system are not exact equivalents; therefore, each system must be used independently of the other. Combining values from the two systems may result in nonconformance with the specification.

5.1 All plates of Grade A and plates of Grades B and C over 1½ in. [40 mm] in thickness shall be normalized. 662m-032007 5.2 Plates of Grades B and C, 1½ in. [40 mm] and under in thickness, are normally supplied in the as-rolled condition. The plates may be ordered normalized or stress relieved, or both.

#### 6. Chemical Requirements

6.1 The steel shall conform to the requirements as to chemical composition given in Table 1 unless otherwise modified in accordance with Supplementary Requirement S17, Vacuum Carbon-Deoxidized Steel, in Specification A 20A20/A20M/A 20M.

## 7. Mechanical Requirements

7.1 *Tension Test Requirements*—The plates, as represented by the tension test specimens, shall conform to the requirements given in Table 2.
