1 Modification to Clause 5 General conditions for the tests

Replace the text of A11:2012 by the following:

5.2 Addition

Add the following to the first paragraph of Part 1:

"The tests of 21.Z101 are carried out on separate appliances."

2 Modification to Clause 7 Marking and instructions

Replace the text of A11:2012 by the following:

7.10 *Modification*

Replace the text of Part 1 "Devices used to start/stop operational ... or position, etc." by the following:

"The accessible switch required by 22.40 shall be distinguished from other manual devices by means of shape, or size, or surface texture, or position, etc."

7.12 Modification

Delete the third and fourth paragraph of Part 1 "The instructions shall include the substance of the following: ... children without supervision:" STANDARD PREVIEW

7.12 Addition (standards.iteh.ai)

Replace the first sentence in the fourth paragraph beginning with "The instructions for **food processors**..." by the following: https://standards.iteh.ai/catalog/standards/sist/d0dc47a2-67de-4bd6-b6e4-

"The instructions for appliances shall warn of potential injury from misuse."

7.12 Addition

Replace the fifth paragraph beginning with "The instructions for hand-held blenders ..." by the following:

"The instructions for appliances shall include the substance of the following:

Always disconnect the appliance from the supply if it is left unattended and before assembling, disassembling or cleaning.

The instructions for bean slicers, berry-juice extractors, **blenders** and **hand-held blenders** churns, centrifugal juicers, coffee mills, **food mixers**, **food processors**, grain grinders, knife sharpeners, knives, **mincers**, noodle makers, potato peelers, shredders, sieving machines and slicing machines shall include the substance of the following:

This appliance shall not be used by children. Keep the appliance and its cord out of reach of children.

The instructions for can openers, citrus-fruit squeezers, cream whippers, egg beaters, graters and ice-cream machines shall include the substance of the following:

This appliance can be used by children aged from 8 years and above if they have been given supervision or instruction concerning use of the appliance in a safe way and if they understand the hazards involved. Cleaning and user maintenance shall not be made by children unless they are aged from 8 years and above and supervised. Keep the appliance and its cord out of reach of children aged less than 8 years.

The instructions shall also include the substance of the following:

Appliances can be used by persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and if they understand the hazards involved.

Children shall not play with the appliance."

3 Modification to Clause 11 Heating

Replace the text of A11:2012 by the following:

11.8 Modification

Replace the first sentence of Part 1 by the following:

"During the test, the temperature rises are monitored continuously and shall not exceed the values shown in Table 3 and Table Z101".

In Table 3, delete the row "External enclosure of **motor-operated appliances**, except handles held in normal use" and the corresponding footnotes.

Add the following Table Z101.

When the thickness of plastic coating does not exceed 0,3 mm, the temperature rise limits of coated metal or glass and ceramic apply.

b Metal is considered coated when a coating having a minimum thickness of 80 μm made by enamel or non substantially plastic coating is used

^c The temperature rise limit applies also for plastic material having a metal finish of thickness less than 0,1 mm.

4 Modification to Clause 20 Stability and mechanical hazards

Replace the text of A11:2012 by the following:

Replace the second paragraph beginning with "The test probe is not applied to....." down to and including Note 102 by the following:

"The test probe, similar to test probe B but having a circular stop face with a diameter of 50 mm, is not applied to:

- a) bean slicers;
- b) can openers;
- c) citrus juice squeezers;
- d) food mixers;
- e) hand-held blenders;
- f) ice-cream machines, including those for use in refrigerators and freezers;
- g) knife sharpeners;

h) knives;

- I) the following parts of other appliances:
 - 1) smooth shafts having a diameter not exceeding 8 mm, rotating at a speed not exceeding 1 500 r/min and driven by motors having an input not exceeding 200 W;
 - 2) outlet sides of grating and shredding disks rotating at a speed not exceeding 1 500 r/min;
 - 3) projections from the surface of grinding disks, cones and similar parts having a height less than 4 mm.

Accessible drive shafts that may not be in use when the appliance is in operation may be protected by means of a collar or by being positioned in a recess.

The test probe 18 is not applied to:

- a) bean slicers;
- b) berry-juice extractors;
- c) hand-held blenders;
- d) can openers;
- e) citrus juice squeezers;
- f) centrifugal juicers;
