Foreword

A proposal to amend EN 60335-2-24:1994, documents CLC/TC 61(DE)455 and CLC/TC 61(FR)248, was discussed during the Oslo meeting in April 1994, when it was decided to submit a draft for an amendment to the voting procedure.

This draft was circulated as prAB in March 1995 and was ratified by CENELEC as amendment A51 on 1995-09-20.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date of publication of an identical national standard (dop) 1996-04-01
- date of withdrawal of conflicting national standards (dow) 1998-04-01

For products which have complied with EN 60335-2-24:1994 before 1998-04-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2003-04-01.

This amendment supplements or modifies the corresponding clauses of EN 60335-2-24:1994.

Subclauses which are in addition to those in IEC 335-2-24 are numbered starting with 601.

There are no special national conditions causing a deviation from this amendment.

There are no national deviations from this amendment.

NOTE - Amendment numbers commencing A1 refer to the endorsement of IEC amendments, while those commencing A51 originate in CENELEC.

The instruction sheet shall include information for cleaning inside the appliance.

The instruction sheet shall include the method for replacing illuminating lamps.

8 Protection against electric shock**8.1 Add:****Modification:**

Lamps are not removed, provided the appliance can be isolated from the supply by means of a plug or an all-pole switch.

21 Mechanical strength**Add:****21.1 Addition:**

Covers of lamps within the appliance are considered likely to be damaged in normal use but not the lamps.

Add:**21.601 Lamps shall be protected against mechanical shock.**

Compliance is checked by applying a 75 mm ± 0,5 mm diameter sphere without appreciable force in an attempt to touch the lamp.

It shall not touch the lamp.
