Delete the following first two lines of the text:

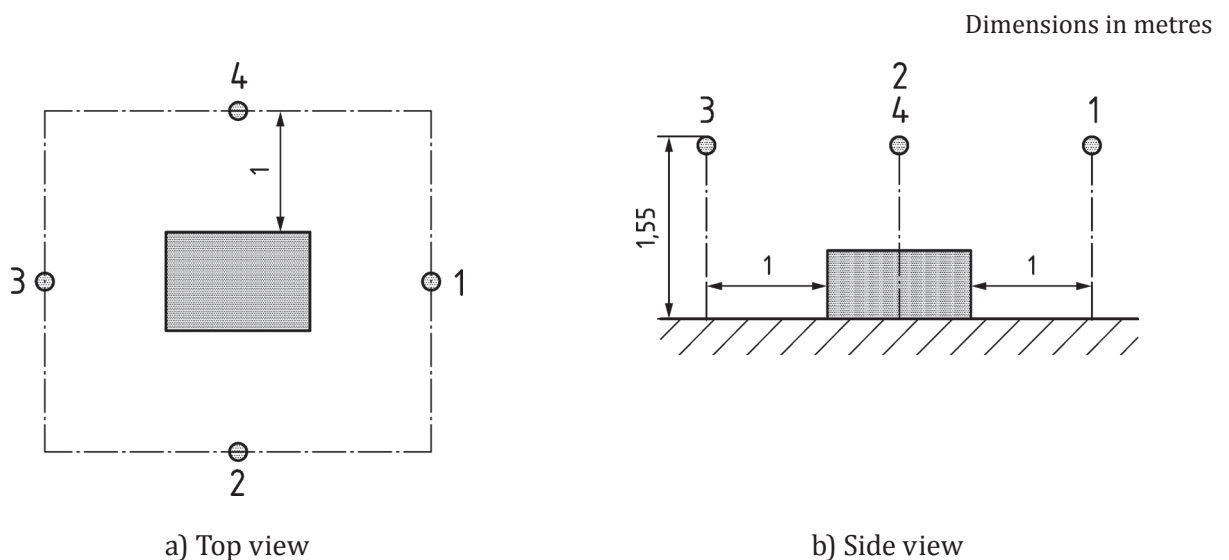

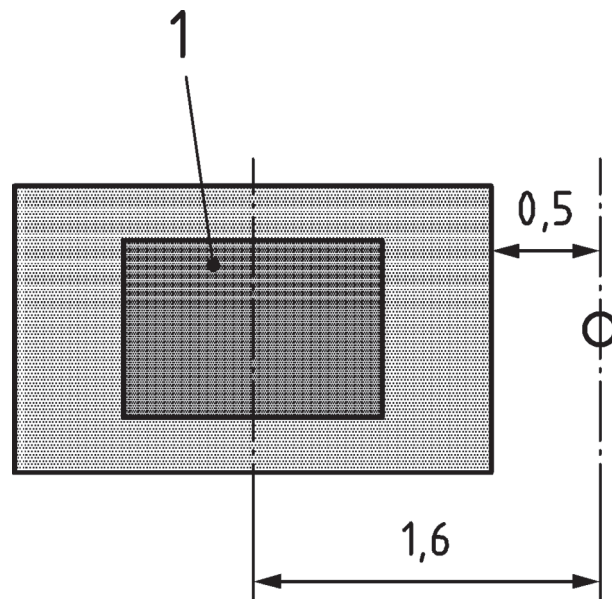
**Figure B.1 — Top and side views of machine and microphone positions**
