1 Scope and field of application

This International Standard specifies a method for the determination of the total ash from tea.

3 Definition

8.1 Preparation of the dish

https://standards.iteh.ai/catalog/standards/sHeat the dish (6:1) for 1 h in the furnace (6.2) at 525 \pm 25 °C. For the purpose of this International Standard, the following /iso-1 Gool in the desiccator (6.5). After cooling, weigh to the nearest definition applies : 0,001 g.

total ash : The residue obtained after incineration at 525 \pm 25 °C under the conditions specified.

4 Principle

Destruction of organic matter by heating at 525 \pm 25 °C to constant mass.

5 Material

5.1 Vegetable oil (for example, olive oil), leaving no residue on incineration.

6 Apparatus

Usual laboratory apparatus, and the following items :

6.1 Dish, of capacity 50 to 100 ml, of platinum, porcelain or other material unaffected by the conditions of the test.

- **6.2** Furnace, capable of being controlled at 525 \pm 25 °C.
- 6.3 Steam bath.
- 6.4 Hot-plate.

8.2 Test portion

Weigh, to the nearest 0,001 g, about 5 g of the ground sample into the prepared dish (8.1). (See ISO 1572.)

Use a ground sample of known dry matter content, prepared as

8.3 Determination

8.3.1 Heat the test portion in the dish, at a temperature near 100 °C until the moisture is expelled. Cool and add a few drops of the vegetable oil (5.1) and heat slowly over a flame until swelling ceases. Transfer the dish to the furnace (6.2) and heat at 525 ± 25 °C until the ash is visibly free from carbon particles (at least 2 h is usually required). Allow to cool, then moisten the ash with distilled water, dry it on the steam bath (6.3) and then on the hot-plate (6.4). Return the dish to the furnace for 60 min, cool in the desiccator and weigh. Heat again in the furnace for 30 min, cool and weigh. Repeat these operations, if necessary, until the difference between two successive weighings does not exceed 0,001 g.

8.3.2 Reserve the total ash for determination of water-soluble ash and water-insoluble ash (see ISO 1576), or of acid-insoluble ash (see ISO 1577), if required.

8.4 Number of determinations

Carry out two separate determinations on the same ground sample (clause 7).

- **6.5** Desiccator, containing an efficient desiccant.
- 6.6 Analytical balance.

9 Expression of results

9.1 Method of calculation and formula

The total ash yielded by the ground sample, expressed as a percentage by mass on the dry basis, is given by the formula

$$m_1 \times \frac{100}{m_0} \times \frac{100}{RS}$$

where

 m_0 is the mass, in grams, of the test portion;

 m_1 is the mass, in grams, of the total ash;

RS is the dry matter content, as a percentage by mass, of reground sample, determined in accordance with ISO 1572.

Take as the result the arithmetic mean of the two determinations, provided that the requirement for repeatability (see 9.2) is satisfied.

9.2 Repeatability

The difference between the results of two determinations, carried out simultaneously or in rapid succession by the same analyst, shall not exceed 0,2 g of total ash per 100 g of ground sample.

10 Test report

The test report shall show the method used and the result obtained. It shall also mention any operating details not specified in this International Standard, or regarded as optional, as well as any circumstances that may have influenced the result.

The report shall include all details required for complete identification of the sample.
