This second edition of ISO 10650 cancels and replaces the first edition ISO 10650:2015, which has been technically revised with the following changes:

- a) The test procedure using filters was deleted.
- b) A test procedure using spectrophotometer was included. 2018
- c) The term "radiant exitance" was changed to "irradiance".
- d) An upper limit to the irradiance for the 385 nm to 515 nm wavelength region was added.
- e) A requirement for the setting delivering a radiant exposure (dose) was added.
