- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1995-09-20

Text of amendment A14

In annex ZA, **delete** the special national condition for United Kingdom regarding subclauses 5.1 and 7.2, and **replace** the text of the special national condition regarding subclause 11.1.3.501 by:

Only plugs according to **(standard sheet B2 in IEC 83)** are allowed.
