This amendment A11 modifies the European Standard EN 60335-1:1994; it was approved by CENELEC on 1995-03-20. CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

This amendment exists in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CENELEC member into its own language and notified to the Central Secretariat has the same status as the official versions.

## Foreword

At the request of the Swedish electrotechnical committees, a draft for an amendment to EN 60335-1:1994 was submitted to the CENELEC members for acceptance in January 1995.

The text of the draft was adapted to include additional information received from Switzerland and was accepted by CENELEC as amendment A11 to EN 60335-1:1994 on 1995-03-20.

NOTE: This amendment A11 includes the corrigendum to EN 60335-1:1994 circulated in January 1995 to correct the text of the special national condition for Austria regarding subclause 19.11.2.

The following dates were fixed:

- latest date by which the existence of the amendment has to be announced at national level (doa) 1995-06-20
- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1995-09-20

In annex ZA, **replace** the first three lines of the special national condition for Austria regarding subclause 19.11.2 by:

An appliance having circuits which may cause, under fault conditions, an earth-leakage current having a d.c. component exceeding 5 mA and exceeding 20 % of the total earth-leakage current shall be

**Replace** the special national condition for Switzerland regarding subclause 25.6 by:

Supply cords of portable household and similar electrical appliances having a rated current not exceeding 10 A shall be provided with a plug complying with SEV 1011 or IEC 884-1 and one of the following dimension sheets:

SEV 6532-2.1991	Plug Type 15	3P+N+PE	250/400 V, 10 A
SEV 6533-2.1991	Plug Type 11	L+N	250 V, 10 A
SEV 6534-2.1991	Plug Type 12	L+N+PE	250 V, 10 A

NOTE: 16 A plugs do not exist in the Swiss domestic system.

In annex ZB, **delete** the A-deviation for Sweden regarding subclause 7.1.
