CENELEC members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for giving this amendment the status of a national standard without any alteration.

This amendment exists in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CENELEC member into its own language and notified to the Central Secretariat has the same status as the official versions.

Foreword

At the request of the Swedish electrotechnical committee, a draft for an amendment to EN 60335-2-31:1990 was submitted to the CENELEC members for acceptance in January 1995.

The text of the draft was adapted to include additional information received from Finland and was accepted by CENELEC as amendment A51 to EN 60335-2-31:1990 on 1995-03-24.

The following dates were fixed:

- latest date by which the existence of the amendment has to be announced at national level (doa) 1995-06-24
- latest date by which the amendment has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1995-09-24

- subclause 22.101 for Finland and Sweden;
- subclause 22.104 for Finland (as added by EN 60335-2-31/A1);
- subclause 30.2 for Finland.
