Foreword

A proposal to amend EN 60335-2-44:1991, document CLC/TC 61 (SE) 323, was discussed during the Paris meeting in November 1994, when it was decided to submit a draft for an amendment to the Unique Acceptance Procedure (UAP).

This draft was circulated as prAA in February 1995 and was ratified by CENELEC as amendment A51 on 1995-11-28.

This amendment has been prepared by the secretariat of CENELEC Technical Committee TC 61.

The following dates are applicable:

- latest date of publication of an identical national standard

(dop) 1996-07-01

 date of withdrawal of conflicting national standards

(dow) 1998-07-01

For products which have complied with EN 60335-2-44:1991 before 1998-07-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2003-07-01.

This amendment supplements or modifies the corresponding clauses of EN 60335-2-44:1991.

9.11 Replace the addition by:

Five min after a protective device has operated, the temperature rise of the surface intended to support the textile material shall not exceed 150 K.

22 Construction

22.101 Add to the second paragraph:

However, the ironing surfaces of flat-bed ironers intended for direct operation by both hands, may be locked in contact with each other, provided that the heating elements are automatically switched off within 15 s by non-self-resetting means and the ironing surfaces separate when the locking means are released.
