This draft amendment is submitted to CEN members for enquiry. It has been drawn up by the Technical Committee CEN/TC 163.

This draft amendment A1, if approved, will modify the European Standard EN 14527:2016. If this draft becomes an amendment, CEN members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for inclusion of this amendment into the relevant national standard without any alteration.

This draft amendment was established by CEN in three official versions (English, French, German). European foreword

This document (EN 14527:2016/prA1:2017) has been prepared by Technical Committee CEN/TC 163 "Sanitary appliances", the secretariat of which is held by UNI.

This document is currently submitted to the CEN Enquiry.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the EU Construction Products Regulation.

For the relationship with EU Construction Products Regulation, see informative Annex ZA which is an integral part of this European Standard.

1 Modification to Clause 4, Classification

Replace the word "Class" *with* "Type" *for both 1 and 2.*

2 Modification to Clause 5, Requirements

Replace the word "Class" with "Type" in the title.

3 Modification to sub-clause 5.3.3.2, Particular requirements for shower trays made of enamelled steel and enamelled cast iron

Replace the word "Class" with "Type" in Table 2 in the parameter column and at the bottom of the table (3 occurrences).

4 Modification to Clause 6, Requirements

Replace the word "Class" with "Type".

5 Modification to Clause 9, Marking, labelling and packaging

Remove all text up to Table 3 and replace with the following:

"The intended use of a shower tray is personal hygiene in accordance with the scope of this standard.

NOTE 1 The intended use is also mentioned in Table ZA.1. The abbreviation 'PH' for the intended use personal hygiene might be used for CE marking.

EXAMPLE 1 Use of full text Personal hygiene.

EXAMPLE 2 Use of abbreviation PH.

Shower Trays can be described with a designation code which includes all the fulfilled essential requirements.

The relevant Essential Characteristics for shower trays including their abbreviations are given in Table 3."

Replace the word "Class" *with* "Type" *in the designation system.*

Delete the text "The second line of the designation code can be omitted when those characteristics are fulfilled."

Change the Example from 1 to 3 and replace the word "Class" with "Type".

Change the Example from 2 to 4 and replace the word "Class" with "Type".

Delete the NOTE.

6 Modification to sub-clause 10.1, General

1st dash, replace the existing text "determination of the product type" with "Type testing (see 10.2)".

7 Modification to sub-clause 10.2.1, General

In the 6th paragraph add the word "Sub-" *before* "type".

8 Modification to sub-clause 10.2.2, Samples, testing and compliance criteria

Add the following text "The number of samples of shower tray to be tested/assessed shall be in accordance with Table 4 and/or Table 5."

Replace the title of Table 4 with "Type testing for type 1 products".

Replace the title of Table 5 with "Type testing for type 2 products".

9 Modification to Annex ZA

Replace the existing text with the following one and remove all declaration of performance statements.

Relationship of this European Standard with Regulation No. 305/2011

(When applying this standard as a harmonized standard under Regulation (EU) No. 305/2011, manufacturers and Member States are obliged by this regulation to use this Annex)

ZA.1 Scope and relevant characteristics

This European Standard has been prepared under standardization request M/110 "Sanitary Appliances" as amended by M/139 given to CEN by the European Commission (EC) and the European Free Trade Association (EFTA).

When this European Standard is cited in the Official Journal of the European Union (OJEU), under Regulation (EU) No 305/2011, it shall be possible to use it as a basis for the establishment of the Declaration of Performance (DoP) and the CE marking, from the date of the beginning of the coexistence period as specified in the OJEU.

Regulation (EU) No 305/2011, as amended, contains provisions for the DoP and the CE marking.

ZA.2 System of Assessment and Verification of Constancy of Performance (AVCP)

The AVCP system(s) of Shower Trays indicated in Tables ZA.1.1 and ZA.1.2, can be found in the EC legal act(s) adopted by the EC: Decision 96/578/EC (OJ L 254 of 8.10.1996 p. 49) amended by EC Decision(s) 2001/596/EC (OJ L 209 p 33 of 2.8.2010) and 2002/592/EC (OJ L 192 p 57 of 20.07.2002).

Micro-enterprises are allowed to treat products under AVCP system 3 covered by this standard in accordance with AVCP system 4, applying this simplified procedure with its conditions, as foreseen in Article 37 of Regulation (EU) No.305/2011.

ZA.3 Assignment of AVCP tasks

The AVCP system(s) of Shower Trays as provided in Tables ZA.1.1 and ZA.1.2 is defined in Table ZA.3 resulting from application of the clauses of this or other European Standards indicated therein. The content of the tasks assigned to the notified body shall be limited to those essential characteristics, if any, as provided for in Annex III of the relevant standardization request and to those that the manufacturer intends to declare.

Taking into account the AVCP systems defined for the products and the intended uses the following tasks are to be undertaken by the manufacturer for the assessment and verification of the constancy of performance of the product.
