European foreword

This document (EN 14516:2015/prA1:2017) has been prepared by Technical Committee CEN/TC 163 "Sanitary appliances", the secretariat of which is held by UNI.

This document is currently submitted to the CEN Enquiry.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the EU Construction Products Regulation.

For relationship with EU Construction Products Regulation, see informative Annex ZA, which is an integral part of this document.

1 Modification to Clause 4, Classification

Delete the word "Class" and replace with "Type" for both point 1 and 2.

2 Modification to Clause 5, Requirements for class 1 products

Replace the heading from "Requirements for class 1 products" to "Requirements for type 1 products".

3 Modification to sub-clause 5.3.3.2, Particular requirements for baths made of enamelled steel and enamelled cast iron

Replace the word "Class" with "Type" in the parameter field of Table 2 (two occurrences).

4 Modification to Clause 6, Requirements for class 2 products

In the heading, replace "class" *with* "type" *to read* ""Requirements for type 2 products".

5 Modifications to Clause 9, Marking, labelling and packaging

Replace the word "Class" with "Type" in Table 3 (two occurrences).

Replace the word "Class" *with* "Type" *in the designation system.*

Delete the following sentence under the designation system: "The second line of the designation code can be omitted when those characteristics are fulfilled".

Replace the word "Class" with "Type" in example 1 and 2.

Delete the note.

6 Modification to sub-clause 10.2.2, Further type testing

Replace the heading of 10.2.2 with "Samples, testing and compliance criteria" and delete the existing text.

Delete the heading of 10.2.3 and add after the 1st *paragraph the following:*

"The number of samples of baths to be tested/assessed shall be in accordance with Table 4 and /or Table 5.".

Change the heading of Table 4 to read: "Type testing for type 1 products".

Change the heading of Table 5 to read: "Type testing for Type 2 products".

7 Modification to Annex ZA

Replace the existing Annex ZA with the new one and remove all Declaration of Performance statements.

Relationship of this European Standard with Regulation (EU) No.305/2011

ZA.1 Scope and relevant characteristics

This European Standard has been prepared under standardization request M/110 Sanitary Appliances as amended by M/139 given to CEN by the European Commission and the European Free Trade Association.

When this European Standard is cited in the Official Journal of the European Union (OJEU), under Regulation (EU) No 305/2011, it shall be possible to use it as a basis for the establishment of the Declaration of Performance (DoP) and the CE marking, from the date of the beginning of the coexistence period as specified in the OJEU.

Regulation (EU) No 305/2011, as amended, contains provisions for the DoP and the CE marking.

ZA.2 System of Assessment and Verification of Constancy of Performance (AVCP)

The AVCP system(s) of Baths indicated in Tables ZA.1.1 and ZA.1.2, can be found in the EC legal act(s) adopted by the EC: Decision 96/578/EC (OJ L 254 of 8.10.1996 p. 49) amended by EC Decision(s) 2001/596/EC (OJ L 209 p 33 of 2.8.2010) and 2002/592/EC (OJ L 192 p 57 of 20.07.2002).

Micro-enterprises are allowed to treat products under AVCP system 3 covered by this standard in accordance with AVCP system 4, applying this simplified procedure with its conditions, as foreseen in Article 37 of Regulation (EU) No.305/2011.

ZA.3 Assignment of AVCP tasks

The AVCP system(s) of Baths as provided in Tables ZA.1.1 and ZA.1.2 is defined in Table ZA.3 resulting from application of the clauses of this or other European Standards indicated therein. The content of the tasks assigned to the notified body shall be limited to those essential characteristics, if any, as provided for in Annex III of the relevant standardization request and to those that the manufacturer intends to declare.

Taking into account the AVCP systems defined for the products and the intended uses the following tasks are to be undertaken by the manufacturer for the assessment and verification of the constancy of performance of the product.
