This draft amendment prAA, if approved, will modify the European Standard EN 62841-3-1:2014; it is submitted to CENELEC members for enquiry.

19	Add the following after 8.14.2 c):
20	8.14.2 Za) Replacement of items 3, 4 and 5 with the following:
21	3) The following information:
22 23	 that the declared noise emission value(s) have been measured in accordance with a standard test method and may be used for comparing one tool with another;
24 25	 that the declared noise emission value(s) may also be used in a preliminary assessment of exposure.
26	4) A warning:
27 28 29	 that the noise emissions during actual use of the power tool can differ from the declared values depending on the ways in which the tool is used especially what kind of workpiece is processed; and
30 31 32 33	 of the need to identify safety measures to protect the operator that are based on an estimation of exposure in the actual conditions of use (taking account of all parts of the operating cycle such as the times when the tool is switched off and when it is running idle in addition to the trigger time).
