This draft amendment is submitted to CEN members for enquiry. It has been drawn up by the Technical Committee CEN/TC 151.

This draft amendment A6, if approved, will modify the European Standard EN 474-1:2006+A4:2013. This draft amendment was established by CEN in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CEN member into its own language and notified to the CEN-CENELEC Management Centre has the same status as the official versions.

European foreword

This document (EN 474-1:2006+A4:2013/prA6:2017) has been prepared by Technical Committee CEN/TC 151 "Construction equipment and building material machines - Safety", the secretariat of which is held by DIN.

This document is currently submitted to the CEN Enquiry.

This document has been prepared under a standardization request given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

For relationship with EU Directive(s), see informative Annex ZA, which is an integral part of this document.

1 Modification to Clause 2, Normative references

Add, in the appropriate order the following new reference:

"ISO 13031:2016, Earth-moving machinery — Quick couplers — Safety."

2 Modification to Clause 3, Terms and definitions

Replace term and definition 3.3 by the following:

3.3

quick coupler

device mounted on an earth-moving machine to allow the quick interchange of attachments

Note 1 to entry: Quick couplers are also commonly referred to under many different names, including "quick hitch" and "attachment bracket". For the purposes of this International Standard, only the term "quick coupler" is used.

3 Modification to 5.21, Attachments and attachment bracket

Replace clause 5.21 and its title by the following:

5.21 Attachments and quick coupler

5.21.1 Attachments

5.21.1.1 General

The machine manufacturer shall define the range of attachments intended to be used with the machine and establish the criteria for the safe fitting and use of the attachment.

Requirements for lifting devices used for lifting operation are defined in Annex C.

5.21.1.2 Identification

The attachment shall be permanently marked with the following information:

- manufacturer's name and address, if relevant;
- type denomination (e.g. part No.);
- mass, expressed in kilograms (kg);
- working circuit pressure, expressed in Mega Pascal (MPa), if relevant;
- capacity of attachment, e.g. expressed in cubic metres (m³), if relevant.

NOTE Interchangeable equipment should bear CE marking within the EEA.

5.21.1.3 Instructions

The attachment manufacturer shall provide instructions concerning mounting and use of the attachment.

5.21.2 Quick coupler

Quick coupler shall meet the requirements of ISO 13031:2016."

This European Standard has been prepared under a Commission's standardization request M/396 to provide one voluntary means of conforming to essential requirements of Directive 2006/42/EC of the European Parliament and of the Council of 17 May 2006 on machinery, and amending Directive 95/16/EC (recast) [2006 L157].

Once this standard is cited in the Official Journal of the European Union under that Directive, compliance with the normative clauses of this standard given in Table ZA.1 confers, within the limits of the scope of this standard, a presumption of conformity with the corresponding essential requirements of that Directive and associated EFTA regulations.
