1 Modification to 5.2.6, "Type D harnesses"

Replace paragraph 5.2.6.2 by the following:

"In the head down position of the dummy, load the harness gradually up to (800 ± 10) N. Under this load, the rope attachment points should be placed approximately symmetrically about the plane of symmetry of the dummy. Mark the tape at the outer edge of any load bearing buckle or adjusting device and apply a force increasing gradually to $(10 + 0,30)$ kN over a period of $(2 \pm 0,25)$ min."
