## Foreword

This Amendment EN 347:1992/A1:1997 to the EN 347:1992 has been prepared by Technical Committee CEN/TC 161 'Foot and leg protectors', the secretariat of which is held by BSI.

This Amendment to the European Standard EN 347:1992 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by August 1997, and conflicting national standards shall be withdrawn at the latest by August 1997.

The amendment is based upon the work of CEN/TC161/WG1 and WG2 and is intended primarily to clarify particular provisions in EN 347:1992, where it was felt that the text could be misinterpreted. This amendment also aligns EN 347:1992 with Amendment 1 to EN 344:1992.

As a consequence of the publication of EN 347-2 the standard EN 347 has been renumbered as EN 347-1 with the following title, Occupational footwear for professional use - Part 1: Specification.

This amendment will be incorporated in EN 347:1992 on the occasion of its first revision.

This Amendment to the European Standard EN 347:1992 has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

According to the CEN/CENELEC Internal Regulations, the national standards organizations of the following countries are bound to implement this Amendment: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the United Kingdom.

In the bottom right-hand corner delete "EN 347 : 1992" and substitute "EN 347-1 : 1992".

**Page numbering**

For all of the numbered pages, on the second line of the page number, delete "EN 347 : 1992" and substitute "EN 347-1 : 1992".

**2 Normative reference**

Delete the normative reference EN 344 and replace with:

## 5 Requirements for occupational footwear

In the third paragraph of NOTE replace "EN 344 : 1992" with "EN 344-1 : 1992"

At the end of the second paragraph of NOTE, add the following text.

"In some cases the requirement relates only to particular materials within the classification - e.g. pH value of leather components. This does not mean that other materials are precluded from use. A clear indication of any limits or exclusions is given in EN 344-1 : 1992, to which reference should be made at all times."

Under the headings "Vamp lining" and "Quarter lining" delete entirely, in each case, the line for "Thickness".

Under the heading "Whole footwear" add "X" in the column for Classification I, against reference 4.3.2.5 "corrosion resistance of metal toecaps".
