## AMENDMENT 1

### 6.1.2 d)

Replace the text with the following:

- d) an assembly consisting of a tube with a side-arm (K) provided with a ground stopper (K'), a pear-shaped enlargement (J), a tube graduated in divisions of 0,05 ml with a volume of at least 3,5 ml (JL), a spherical enlargement (L) and a three-way tap (M) connected to the vertical tube (AC) by an inclined tube (O) provided with a safety tube (N), if necessary topped by the steam trap (6.1.3).

Replace the text with the following:

- 1) This apparatus corresponds to the type described in the *European Pharmacopoeia* (V 5.89), 2.8.12 with modifications according to (6.1.2 d).
