This Amendment EN 467:1995/A1:1998 to EN 467:1995 has been prepared by Technical Committee CEN/TC 162 "Protective clothing including hand and arm protection and lifejackets", the secretariat of which is held by DIN.

This Amendment to the European Standard EN 467:1995 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by May 1999, and conflicting national standards shall be withdrawn at the latest by May 1999.

This Amendment to the European Standard EN 467:1995 has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

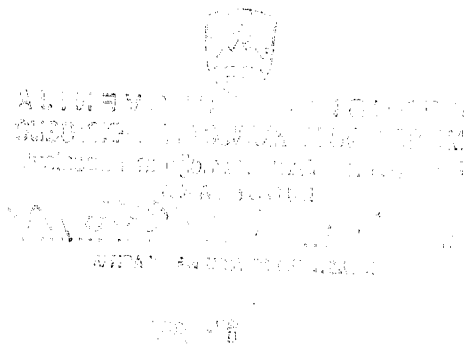

Annex A (normative)**Glass paper and glass cloth****A.1** Quality of materials

A.1.1 Abrasive: The glass used shall be of good quality and suitable for the purpose.

A.1.2 Backing: The backing shall be of good quality paper or good quality cloth, plain weave.

A.1.3 Adhesive: The adhesive, which may be water soluble, shall be of good quality and suitable for the purpose.

A.2 Form and dimensions: The glass paper or glass cloth shall be supplied in sheets of (230 ± 2) mm x (280 ± 3) mm, to the minimum mass as specified in table A.1.

Table A.1: Mass of glass paper or glass cloth

No. 00 glass paper	6,5 kg
No. 00 glass cloth	8,0 kg

If required, the glass paper or glass cloth shall be supplied in rolls.

A.3 Abrasive Grain: The abrasive grain used in the manufacture of glass paper or glass cloth shall be specified in the grade number on the back of each sample and shall comply with the grading requirements of table A.2.

A.4 Breaking strength: The breaking strength of the finished glass paper or glass cloth, expressed in newtons per 50 mm of width, shall not be less than specified in table A.3.
