#### Foreword

The proposal to endorse IEC 335-2-47:1995, document CLC/TC 61 (SEC) 1015, was circulated under the enquiry procedure in June 1995. This proposal was discussed during the Copenhagen meeting in May 1996, when it was decided to submit a draft for EN 60335-2-47 to the formal vote.

This draft was circulated in September 1996 and was ratified by CENELEC as EN 60335-2-47 on 1997-03-11.

This European standard has been prepared by the secretariat of CENELEC Technical Committee TC 61.

#### **FOREWORD**

- 1) The IEC (International Electrotechnical Commission) is a worldwide organization for standardization comprising all national electrotechnical committees (IEC National Committees). ## SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES

# Part 2: Particular requirements for commercial electric boiling pans

#### 1 Scope

This clause of part 1 is replaced by:

This standard deals with the safety of electrically operated commercial **boiling pans** not intended for household use, their **rated voltage** being not more than 250 V for single-phase appliances connected between one phase and neutral, and 480 V for other appliances.

NOTE 1 - These appliances are used, for example, in kitchens such as in restaurants, canteens, hospitals and commercial enterprises such as bakeries, butcheries, etc.

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

So far as is practicable, this standard deals with the common hazards presented by these types of appliances.

## NOTE 2 - Attention is drawn to the fact that:

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- for appliances intended to be used in tropical countries, special requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities;
- in many countries additional requirements are specified for pressure appliances.

## This standard does not apply to:

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
  - continuous process appliances for the mass production of food;
  - appliances with electrode heaters.

#### 2 Definitions

This clause of part 1 is applicable except as follows:

#### 2.2.4 Addition:

NOTE – The **rated power input** is the sum of the power inputs of all the individual elements in the appliance which can be on at one time; where there are several such combinations possible, that giving the highest power input is used in determining the **rated power input**.
