The proposal to endorse IEC 335-2-48:1995, document CLC/TC 61 (SEC) 1016, was circulated under the enquiry procedure in June 1995. This proposal was discussed during the Copenhagen meeting in May 1996, when it was decided to submit a draft for EN 60335-2-48 to the formal vote.

This draft was circulated in September 1996 and was ratified by CENELEC as EN 60335-2-48 on 1997-03-11.

This European standard has been prepared by the secretariat of CENELEC Technical Committee TC 61.

For products which have complied with EN 60335-2-48:1990 including its amendment A1:1992 before 1999-12-01, as shown by the manufacturer or by a certification body, this previous standard may continue to apply for production until 2004-12-01.

FOREWORD

- 1) The IEC (International Electrotechnical Commission) is a worldwide organization for standardization comprising all national electrotechnical committees (IEC National Committees). SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES

Part 2: Particular requirements for commercial electric grillers and toasters

1 Scope

This clause of part 1 is replaced by:

This standard deals with the safety of electrically operated commercial **grillers** and **toasters** not intended for household use, their **rated voltage** being not more than 250 V for single-phase appliances connected between one phase and neutral, and 480 V for other appliances.

Rotary or continuous grillers and toasters and similar appliances intended for grilling by radiant heat such as rotisseries, salamanders, etc. are within the scope of this standard.

NOTE 1 - These appliances are used, for example, in restaurants, canteens, hospitals and commercial enterprises such as bakeries, butcheries, etc.

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

So far as is practicable, this standard deals with the common hazards presented by these types of appliances.

NOTE 2 - Attention is drawn to the factithat ai/catalog/standards/sist/e04136c9-eba4-4d22-aa4c-

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- for appliances intended to be used in tropical countries, special requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities;
- for appliances intended to be used outdoors, additional requirements may be necessary.

This standard does not apply to:

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- continuous process appliances for the mass production of food;
- griddles and griddle grills (IEC 335-2-38).

2 Definitions

This clause of part 1 is applicable except as follows:

2.2.4 Addition:

NOTE – The **rated power input** is the sum of the power inputs of all the individual elements in the appliance which can be on at one time; where there are several such combinations possible, that giving the highest power input is used in determining the **rated power input**.

2.2.9 Replacement:

normal operation: Operation of the appliance under the following conditions:

Appliances are operated with no load and with any controls intended to be operated by the user set at the maximum. Timers, if provided, are rendered inoperative.

If doors, lids, reflectors or drip trays are provided, they are arranged in accordance with the manufacturer's instructions. If no instructions are given, doors are fully open, drip trays are put into the lowest and the grilling grid into the highest possible position.

If the appliance cannot be operated without a load, then the manufacturer's instructions are taken into account.

ITeh STANDARD PREVIEW

Motors incorporated in the appliance are operated in the intended manner under the most severe conditions which can be expected in normal use taking into account the manufacturer's instructions.

- 2.2.101 griller: An appliance in which food is cooked by being exposed mainly to radiant heat.
- 2.2.102 **toaster:** An appliance intended exclusively for browning bread and similar products by radiant heat.
- 2.2.103 rotary or continuous griller or toaster: An appliance where the product is moved while being grilled or toasted.

3 General requirement

This clause of part 1 is applicable except as follows:

Addition:

NOTE 101 - The d.c. component in the appliance neutral is limited (Australia).

4 General conditions for the tests

This clause of part 1 is applicable except as follows:

4.101 Appliances are tested as heating appliances, even if they incorporate a motor.

4.102 Appliances, when assembled in combination with or incorporating other appliances, are tested in accordance with the requirements of this standard. The other appliances are operated simultaneously in accordance with the requirements of the relevant standards.

If a part of the appliance or the whole appliance is intended to be used for different functions covered by different standards, the relevant standard is applied to each function separately, so far as is reasonable.

5 Void

6 Classification

This clause of part 1 is applicable except as follows:

6.1 Replacement:

Appliances shall be of class I with respect to protection against electric shock.

Compliance is checked by inspection and by the relevant tests.

NOTE - Class 0i appliances are allowed (Japan).

6.2 Addition: iTeh STANDARD PREVIEW

NOTE 101 – For appliances intended to be installed in a kitchen, an appropriate degree of protection against harmful ingress of water is required according to their height of installation (France).

- 6.101 With respect to protection against temperature rise due to installation conditions, appliances shall be classified as follows:

 39ecd3aaa6a7/sist-en-60335-2-48-1998
 - appliances intended for installation in isolation;
 - appliances intended for installation in a bank of other appliances.

NOTE - There are no additional requirements for appliances intended for installation in a bank of other appliances at present.

7 Marking and instructions

This clause of part 1 is applicable except as follows:

7.1 Addition:

In addition, appliances shall be marked with:

- the water pressure or range of pressures, in kilopascals (kPa), for appliances intended to be connected to a water supply, unless this is indicated in the instruction sheet:
