## Rotary disc and drum mowers and flail mowers

### AMENDMENT 1

#### *Clause 2*

Replace the reference to ISO 5718:2002 with the following:

ISO 5718:2013, *Harvesting equipment — Blades for agricultural rotary mowers — Requirements*

#### *Subclause 5.6, second paragraph*

Replace the second list item by the following text:

“— the controls for adjustment shall be located on the top, or at the sides, front or rear of the mowing machine, at a maximum horizontal distance of 550 mm within the overall outer limits of the machine, and, in addition, in case of mounted mowers, ISO 4254-1:2008, 6.1.2 applies.”
