Page 1, Clause 2

ISO 2859-1, Sampling procedures for inspection by attributes -- Part 1: Sampling schemes indexed by acceptance quality limit (AQL) for lot-by-lot inspection

ISO 3951-1, Sampling procedures for inspection by variables -- Part 1: Specification for single sampling plans indexed by acceptance quality limit (AQL) for lot-by-lot inspection for a single quality characteristic and a single AQL

Page 2, Clause 6

Replace “ISO 1886” by “ISO 2859-1 and ISO 3951-1”
